I understand and acknowledge that the firearms training indicated above involves the use of live ammunition, movement, and other physical activity and has the potential for injury, damages, or death. I agree to voluntarily accept these risks.

Any failure on my part to maintain a safe atmosphere, and therefore endangering myself or others will constitute grounds for immediate dismissal from the class. The decision of my dismissal is without recourse and at the sole discretion of Langdon Tactical Technology, Inc.
